We will try to limit our food booths and crafts booths to one vendor of each food type, but this is NOT a guarantee. If you have attended in previous years and would like your same spot, please remit application and payment ASAP. **All spots are FIRST COME, FIRST SERVE! Make sure you have all your permits with you. If you will be running a food booth, it is up to you to make sure you have the proper permits- (the Health Inspector does come around to check each food vendor) Cowboy Days will not be responsible if you do not have the proper permits and your booth gets shut-down for health reasons.**

FOOD BOOTH - \$70.00 + \$10.00 if you want electricity

CRAFT/OTHER BOOTH - \$60.00 + \$10.00 if you want electricity

FRIDAY NIGHT ONLY BOOTH- \$25.00 + \$10.00 if you want electricity

Booth space for Craft and/or game areas are 12x12 spots, therefore if you will need a larger area, please pay for two booth spaces. **Set-up time for the Friday Night Downtown event Friday, September 4th is still TBD, September 5th at the Fairgrounds from 7:30 AM- 9:30 AM.
